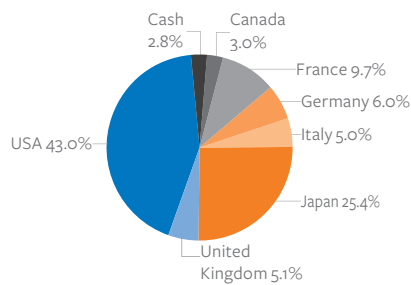

The amount paid depends on applicable tax laws and whether or not the fund is held in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.</p> <p>Keep in mind that for funds held in a non-registered account, fund distributions are included in taxable income, whether they are received in cash or reinvested in additional units of the fund.</p>																
<p><b>How much does it cost?</b></p> <p>The following outlines the fees and expenses associated with buying, owning and selling Class D units of the Fund. The fees and expenses are different for each class. Ask about other classes that may be more suitable.</p> <p><b>1. Sales charges</b></p> <p>No-Load: No purchase/redemption charges apply if purchased directly through McLean Budden. If purchased from a broker, certain charges may apply.</p> <p><b>2. Fund expenses</b></p> <p>You don't pay these expenses directly. They affect you because they reduce the class' returns.</p> <p>As of June 30, 2011, the Fund's expenses were 1.43% of its value. Dealers may pay part of the trailing commission to their representatives.</p> <p>The trailing commission of 0.10% is paid out of the management fee. This equals \$1.00 each year for every \$1,000 invested.</p> <p><b>3.
